Dear Alderman Solis:

I met with Ms. Elizabeth Rodriguez, owner of Ellehomme Spa, a premiere boutique medspa located at 832 W. Adams Street, Chicago, Illinois, in August 2016 to discuss and review her request to lift Liquor Moratorium 4.60.022.27.235.

Ellehomme Spa has been in business since 2008. Ellehomme Spa offers a variety of aesthetic science and holistic therapies to over 3,000 of their clients. The Spa is open 7 days a week, Monday thru Friday 9am-8pm, Saturday 10am-6pm and Sunday 10am-4pm.

The request is to lift Liquor Moratorium 4.60.022.27.235, which extends along Adams Street, from the John F. Kennedy Expressway (I-90) to Morgan Street, for the purpose of allowing consumption of alcohol on premises. Ellehomme Spa would like to serve their clients champagne and wine during their visit at the Spa.

At this time, West Loop Community Organization does recommend the lifting of Liquor Moratorium 4.60.022.27.235. It is understood that lifting the moratorium would not guarantee the issuance of a liquor license, all liquor license applications must be approved by the City of Chicago's Liquor Commission. The Commission may consider the opinion of the aldermen and the community in the decision. If the moratorium is lifted, it will remain lifted for no more than 12 months, after which time West Loop Community Organization requests that the Alderman re-introduce the ordinance of the Liquor Moratorium (27.235) on or before November 30th, 2017.
